

#### **Purpose of Committee:**

Elves Location & Planning Committee offers oversight toward matters associated with capital planning, building and equipment upgrades, and facility maintenance including annual inspections and Hemisphere Study upgrades. The Committee addresses improvements with consideration to services in conjunction with Society revenues received through operations and fundraising initiatives. The Fundraising Committee works toward acquisition of donations and grants that will meet these outcomes.

# Major Capital Upgrades Capital Planning

In 2010, Elves undertook the commissioning of a Capital Replacement Study in partnership with two Engineering firms. The study provided recommendations for necessary mechanical, heating, electrical, outer envelope, and systems replacements which have guided capital priorities over the past 15 years. Elves is currently undertaking to have a replacement report conducted which, similarly, will identify needs over the next 25 years.

#### **Preventative Maintenance and Inspections**


Across all locations, Elves conducts routine preventative maintenance at our facilities. There are also associated inspections by the Fire Marshall and Public Health Inspector to ensure that our facilities are safe for all staff, students/clients and visitors.

#### **Elves Adult and Youth Centre (EAYC):**

- Completion of a roof replacement project at a cost of \$140,000.
- Expansion of our gardening spaces, enhancing outdoor learning and therapeutic activities.
- Continued work towards finalizing the permanent gazebo installation which will provide a shaded, welcoming space. Projected completion is summer 2026.
- Plexiglass paneling was added along ramps to increase fall protection for children and clients.
- Major floor and ceiling lift systems (near or over 10 years old) are being replaced to ensure safety and functionality. Seven units were replaced, while other lifts were inspected or repaired at costs over \$50,000.
- > Two septic pumps were replaced at the Elves Adult and Youth Centre.




#### **Elves Child Development Centre (ECDC):**

- Installation of a new building sign.
- Outdated playground equipment and planter boxes were removed.
- New patio fencing was installed in July 2025 to create safer outdoor spaces.



#### **Technology Improvements**



89 computers were replaced to meet Windows 11 requirements. Elves also secured Microsoft licensing agreements through the Ministry of Education and Childcare to reduce retail/commercial licensing costs.



# **Parent Advisory Council (PAC)**

#### **Purpose of Council:**

The School Act and Private Schools Regulations require that independent schools have a Parent Advisory Council (PAC) to work with School Administration and Elves' Board of Directors. At Elves, the Council includes parent representation from our School and Adult Programs. PAC offers guidance and ongoing feedback to Elves' Administration in matters related to parent education and delivery of Elves' services.

Parent Advisory Council met twice over the course of the year to review priorities and PAC family events that were hosted by Elves or other community groups. Priorities for the past year included providing families with access to experts who could offer information related to financial stability (Wills, Estates, and Registered Disability Savings). Transitional Planning (School, Adulthood, Guardianship, and Residential services. There were also sessions to address access to and management of Family Supports for Children with Disabilities and Persons for Persons with Developmental Disabilities.

Emergency preparation was addressed in two sessions. The first addressed Elopement, and the second event looked at Emergency Responses for accidents, fires, and domestic abuse.

#### **Purpose of Committee:**

The Finance Committee is integral in offering oversight and expertise to annual approve the Society's budget and Audited Financial Statements and monitor spending throughout the year.

Elves receives the majority of its funding from the Government of Albert Ministries of Education and Assisted Living and Social Services. We also have other funding sources which include: Fetal Alcohol Spectrum Disorder Cross Ministry Initiative, various Service Agreements with School Boards for services to some Grades 1-12 learners. Elves has discretionary use of funds received in conjunction with Service Agreements and fundraising. Elves' Board of Directors actively support staff retention initiatives and facility maintenance as priorities for the 2025/2026 year.

#### **Elves' Annual General Report**

September 01, 2024 to August 31, 2025

In 2024/2025, the Finance Committee met three times, with further information being presented to the Board for approval of actions. There were also multiple engagement opportunities to address investment of reserves and management of staff compensation.

In October 2024, there was a review of the approved budget to ensure that operations continued to align with planning undertaken in April 2025.

The Finance Committee also met with Elves' Auditor prior to Audited Financial Statements being presented to Elves' Board and later to Society members for approval. The 2025/2026 budget was approved by Elves Board of Directors in April 2025.

Audited Financial Statements were prepared by Yaremchuk Annicchiarico LLP. #### **Executive Director Report**

Elves provides educational, day, and respite services to children, youth, and adults (program participants). During the 2024–2025 year, we supported 435 individuals across our programs. We rely upon safe and caring environments, and expert staff to support the program participants enrolled in our School, Community Access Adult Program or site-based Respite services.

#### **Program Locations**

Elves' services are delivered through two primary facilities:

- **Elves Child Development Centre** owned by the Government of Alberta. Elves occupies the building under a Non-Government Space User Agreement.
- Elves Adult & Youth Centre owned and operated by Elves Special Needs Society.

#### **Program Operations**

- School Program: Operates from mid-summer through the end of June.
- Adult Program: Operates year-round.
- FASD Respite Program: Operates on Saturdays from September through June.
- **Summer Program:** Runs during the first three weeks of July.

To ensure Elves is maintaining compliance with service agreements with our major funders, we maintain preventative and capital replacement and life safety and public health inspections. These are completed annually; Elves must share inspection results with our major funders and insurance providers.

#### **Service Delivery**

Elves employs approximately 200 full and part-time staff members, including regulated and non-regulated staff. Contracted professionals provide specialized support in speech and language, occupational therapy, and psychological services. We are thankful for the dedication of our senior team members and for the enthusiasm of new staff joining our community.

Over the past year, we entered contracts with Alberta Health Services for ad hoc translation support and annual specialized training in the management of complex airways. In August 2024, frontline and specialist school program teams participated in training to evolve responses to the changing complex airway needs of some students. Elves has introduced a new nursing position within classroom teams to better support learners for these complex needs. Twenty members of the School Program team completed both on and off-site training to enhance their ability to manage airway care, equipment, and emergency tracheostomy reinsertion in the event of decannulation. Contracted nursing support was also secured to provide suctioning assistance for several learners during transportation to and from school.

We celebrate the composition of our staff which reflects core values of diversity and inclusivity. In 2024 our workforce composition was comprised of:

In the spring of 2025, the Elves Adult Program bid farewell to long-time staff member and Staff Trainer, Shauna White, upon her retirement. The nursing team also experienced transition as a School Program nurse, moved into a vacancy within the Adult Program Nursing Department. Elves subsequently hired a returning staff member—previously part of the Adult Program—to fill a Licensed Practical Nurse position following staff resignations and medical leaves. Contracted occupational therapy services from LifeMax Occupational Therapy Inc. were also secured in the spring to support Elves Adult Program needs. Our previously employed part-time OT returned to Elves in October 2025 to provide services one to two times per month.

In October 2024, after 34 years of service Elves Executive Director, Barb Tymchak Olafson announced her retirement plans for fall, 2025. An area of focus for 2024–2025 has been to maintain smooth management of Elves' operations while preparing for the transition to the new Executive Director. After an extensive search, the Elves Board of Directors selected Blayne Blackburn, who joined Elves as Executive Director on September 15, 2025. Barb provided transitional support for Blayne until the end of October 2025 and will provide occasional consultation until early 2026.

#### **FUNDING**

The following Ministries fund Elves programs:

- Ministry of Education and Childcare
- Ministry of Assisted Living and Social Services (Programs for Persons with Disabilities (PDD), Family Support for Children with Disabilities (FSCD) and Children's Services
- o Fetal Alcohol Spectrum Disorder (FASD) Cross Ministry Initiative

Access to services offered in Elves programs is contingent on individuals meeting ministerial qualifications for citizenship, special needs/severe disabilities and attendance. Funding to Elves is reduced when program participants cease to access Elves' services due to numbers served, which are impacted by age, relocation, or health or program participants. Facility space is also a factor that impacts the number of persons that Elves can serve each year.

# Elves' Programs

Elves operates a School Program, Adult Community Access Day Program, and FASD Respite and Summer Programs. The programs are housed in Elves Child Development Centre (ECDC) and Elves Adult & Youth Centre (EAYC).

# Elves' Adult Community Access Day Program



Elves' Adult Program primarily supports adults with significant medical or intellectual disabilities who require intensive assistance in developing life skills, enhancing social and emotional well-being, and maintaining self-help and personal hygiene routines. Individuals with complex neurodevelopmental profiles and behaviors of concern are also expertly supported by Elves.

The Elves Adult Program employs 58 full-time staff and receives support from other part-time or casual personnel. The program operates on a cost-absorption model, with individualized funding prepared by Elves to

reflect each client's specific support needs. Services include instructional guidance, nursing care, occupational therapy, behavioural support, and community access opportunities. Administrative cost for operations are allocated on sole or shared use basis with the Elves School Program. Shared use allocations are determined on a 30/70% ratio reflective of Adult to School Program funding.

The program runs daily Monday to Friday, and instructors offer a structured routine within each room to help clients engage in activities that reflect their interests and abilities. To protect the health and well-

being of all participants, nursing and Occupational therapy support enables active engagement at each

person's maximum potential.

Goals are determined based on assessment of need, client preferences and parental/guardian consent. Clients typically participate in community-based experiences such as volunteer work, recreation, and program-related outings.








#### **Elves School Program**

Elves Special Needs Society operates educational programs at the Elves Child Development Centre and Elves Adult & Youth Centre. Elves is a non-profit, accredited School and Designated Special Education Program (DSEP) that serves children in an Early Education Program who are engaged in our Grades 1-12 classrooms. All Elves' learners have severe disabilities which may impact communication, intellect, mobility, health, adaptive skills, and psychosocial well-being.

Families or authorized decision makers enroll their children at Elves and provide consent for interventions outlines in the Individual Program and Therapy Plans. Consent is also required for photographs, community access and other interventions with external service providers such as the Alberta Health Services including; Psychiatry, Clinic iCan Centre, Feeding and Swallowing Clinic and Provincial Integrated Respiratory Supports (PIRS Team). Elves also contracts external service providers for speech and language and psychoeducational assessments. We are excited to have plans during 2025/2026 for some pediatric Glenrose Seating Clinic appointments to be conducted at Elves.







Elves Special Needs Society operates Elves' School Program in two specialized facilities in which 110 full, part-time and casual personnel meet the needs of special needs learners. Students and children in the

classrooms are placed into groupings based on ages and abilities. Children (between ages 2.8 to 6), and students (person to 20) who attend Elves, qualify for Program Unit Funding (PUF) or Grades 1-12 Severe Disabilities Funding.

In addition to ensuring that children and students come to Elves ready to learn, it is also essential that the school provide individuals with severe disabilities and complex needs, a unique, comprehensive, individualized educational and therapeutic program for lifelong learning, including transitional supports upon graduation. Elves' programs ensure a supportive and caring environment that maximizes every individual's potential and those who care for them.







The Ministry of Education and Childcare, classifies the Elves' School Program as an Independent School that operates a Designated Special Education Program (DSEP). During the 2024-2025 year, Elves met the following compliance requirements with the Ministry of Education and Childcare:

- ✓ Transportation Grant

In May 2025, Elves also successfully completed a multi-day Ministry of Education and Childcare, School Review site-based compliance review which occurs on a three-to-five-year cycle. Standards tested included access, accountability, assurance and appeals. The review also included comprehensive testing against operations and policies, student cumulative files, assessment process and results, reporting processes, and Society policies. The representatives also met with the teaching team, families, leadership and the Board President.

Elves' operations are tracked specific to Ministry of Education and Childcare. Childcare priorities through the Annual Education Results Report (AERR). Staff and parents of learners in specific age categories are surveyed by the Ministry. The results below reflect the teacher responses only due to low parent responses (i.e. under 6 are not reflected).





Elves conducts parent surveys for all families. The green column in the graphs reflect the rates of parental satisfaction with Elves School Program Services and Supports






96% of respondents were satisfied that Elves provides a safe and caring environment for all learners. Valuable feedback was given related to transportation consistency impacted by weather, road conditions, wait times and changes in ridership or drivers.

Elves' learners present with severe disabilities that preclude them from participating in Provincial Achievement Testing. There are standardized and observational measures that are utilized to determine most appropriate educational plan and specialist supports, as well as tracking progress. In general, there is a high satisfaction level with Elves' services reflected in both the Alberta Education and Elves' surveys. Overall, Elves' levels are greater than the satisfaction reflected in the provincial average. 



- > 75% 100% Skills are being **Met** or Advancing. Goals may be maintained or criteria will be increased.

IPP goals are established with engagement of the Elves team and parents or caregivers of children and youth. Goals are set based on learner ability and needs. 100% of learners made progress over the course of the year. Key points:

- A total of 84% of goals established for early childhood learners (ECS) were met at 75-100% during the year.
- This year there were 59% of goals for the Grades 1-12 learners met at 75-100% range.
- There were 67% of IPP goals set for ECS were met at a level of 51-75% proficiency and 54% of criteria set for Grades 1 -12 learners was met at the 51-75%.
- Learners who achieved less that 50% of the IPP goals, may have experienced factors associated with well-being and criteria was not adjusted for those factors. When achievement is less than 50%, criteria must be reassessed. Significant modifications to IPP criteria or procedures are always shared for approval by authorized decision makers.

Parents provide consent for goals and attend IPP (Individualized Program Plan) meetings. There are also other options for parents and caregivers of early education learners to come to the school for demonstrations of learning on days when no school is in session.

Technical innovations and parent management continued throughout the year during Open Houses, Parent Team Meetings, Parent and Child Engagement Sessions and Elves or Board hosted events. Over the year, Elves' staff have continued to participate in training that supports understanding traumarelated training, disabilities (primarily Autism and Fetal Alcohol Spectrum Disorder) and accountability (curriculum-related changes) and reconciliation (Metis Awareness by Metis Nation of Alberta). Elves provided opportunities for families to join educational sessions or IPP meeting virtually or in person.

#### **Elves' Respite Services**

Elves' FASD Respite Program is funded through the FASD Cross Ministry Initiative, overseen by the Edmonton Fetal Alcohol Network (EFAN). The program is held on Saturdays from September to June.



As a network member, Elves was successful in being approved for a Healthy Outcomes grant from the Edmonton Fetal Alcohol Network. Our priorities were to enable several children without Government of Alberta funding to attend the Elves Summer Program, support the purchase of more science related items to support child focus and regulation, and purchase tools for children's health. With funds, Elves acquired blenders and hosted

an information session to support families to make smoothies that will enable better stomach biome for persons with FASD.

The FASD Respite Program provides a supportive, non-educational environment where children develop

social skills and meaningful friendships through structured play and group activities. Serving up to 33 children over a ten-month period, the program is supported weekly by up to 15 staff members who work collaboratively with children and their families. Participants benefit from the expertise of a multidisciplinary team skilled in supporting individuals with Fetal Alcohol Spectrum Disorder. Program staff carefully adapt activities and daily routines to accommodate each child's interests and developmental needs, ensuring opportunities for



social interaction and recreational engagement appropriate to their developmental levels.

# Elves' Summer Program

Elves' Summer Program is offered for three weeks in the month of July. The Program is funded through

The FASD Respite Program provides a supportive, noneducational environment where children develop social skills and meaningful friendships through structured play and group activities. Serving approximately 30 children over a ten-week period, the program is supported by up to 15 staff members who work collaboratively with children and their families. Participants benefit from the expertise of a multidisciplinary team skilled in supporting individuals with Fetal Alcohol Spectrum Disorder. Program staff carefully adapt activities and daily routines to accommodate each child's interests and developmental needs, ensuring opportunities for social interaction and recreational engagement appropriate to their developmental levels identified in the Ministry of Assisted Living and Social Services, Children's Services and the FASD health Outcomes Grant. The Program



offers respite to families, and therapeutic intervention to children/youth. Individuals attending the program benefitted from peer interactions in a small group environment. Access to gym space, playground, jumpy castles, and bubble machines enabled children to maintain skills with a play-based focus.

#### **Translation Supports**

As there is a greater diversity in Elves' community, we secured a contract for on-demand translation supports through AHS representation.

#### **Provincially Integrated Respiratory Services** (PIRS)

In September 2024, the Provincially Integrated Respiratory Services (PIRS) supported Elves policy review and staff training to ensure safe supports for a growing number of individuals with complex airways and ventilators. To date, four nurses participated in full-day training and nine staff attended half-day sessions related to ventilator management. There was also curriculum developed, and instruction provided to enable 20 multi-disciplinary staff to participate in full-day training and an additional half- day simulation training.
